Mental Health and Suicide Awareness; Tuesday 15th July 11 am - 12. 30 pm



2. Safer Recruitment- demisterfied!

Based on the safeguarding cases in our region, we know that one of the biggest things that churches, projects, and circuits can do to keep people safe is make sure safer recruitment is followed. We know it's complicated- so here are some things that might help.

3. Safeguarding in the News- Apology for Mother and Baby Homes

The Methodist Church used to run homes to support single mothers, but some women experienced harsh conditions, neglect and abuse. The Church has now formally apologised to anyone who has been hurt or abused in any of the Mother and Baby Homes that it was responsible for in the past. 4. New Ways of Seeing: Re-interpreting Annunciation by Eric Gill

The Survivor's Group have advised the church to reinstate a painting by Eric Gill, an artist who abused, to the Methodist Modern Art Collection (MMAC), but with an explanation of the artist's past. They have worked with curators to retell the story.

The Survivors Group have written powerful reflections and responses which are now part of the MMAC Webpage page on this painting, and are co-curating a exhibition. This collaboration even featured in the <u>Guardian</u>!
